

## **Dance Shack Terms & Conditions - 2023**

### **PLEASE READ CAREFULLY**

#### A. Fees

1. A discount on fees is offered to students who attend more than one class or whose siblings attend.
2. All classes are payable per term in advance, or by subscribing to a monthly membership plan.
3. Refunds will not be given for non-attendance through sickness, holidays or otherwise.
4. If a class is cancelled due to the sickness of the teacher, a health epidemic or any other seen or unforeseen event, we will endeavour to provide a cover teacher or reschedule the class. This may be on a different day or a different time or both from when the class was originally scheduled, and might involve an extension to the term time dates. No refunds will be given in this case. The most likely result will simply be a replacement teacher.
5. We will always endeavour to keep our classes running, but in the unlikely event of a class being cancelled due to exceptional weather, parents will be informed as early as is practical by email and/or text. No refunds will be given in this case.
6. By completing this form, you are enrolling your child into a rolling course of Dance Shack classes. At the end of your first term, your child will automatically be enrolled in the following term and so on. **One half term's (six weeks) written notice or payment in lieu is required if you wish to withdraw from classes at Dance Shack.** For the sake of clarity, the six weeks referred to are term-time, payable weeks, and do not include holiday weeks. **This notice period will not apply during or at the end of a child's first term at Dance Shack.**
7. Dance Shack reserves the right to change fees or timetable with at least six weeks prior notice.

#### B. Classes

1. Students should arrive promptly, correctly dressed and attend classes regularly.
2. Please inform your teacher of any injuries before class.
3. Physical contact maybe necessary when helping to demonstrate or correct.
4. It is important to drink fluids at regular intervals during physical exercise, students should bring water bottles. There is a water fountain available in or near all our studios.
5. During class students are expected to listen and although the ethos of Dance Shack encourages individuality and enjoyment, behaviour that detracts from the learning process and disrupts the class for other students is unacceptable. If a student is causing disruption, they may be asked to leave their class. Dance Shack reserves the right to refuse entry to any class at our discretion.

#### C. Uniform

1. Dance Shack has a uniform which can be ordered through the school.
2. There is no obligation to purchase uniform for the first term, but it is expected that all students should attend class in uniform from their second term onwards.

#### D. Photography/video

1. You hereby give Dance Shack permission to use any still and/or moving image being video footage, photographs and/or frames and/or audio footage depicting your child named above, for any of the following uses:
  2. To be displayed on the website, [www.danceshack.co.uk](http://www.danceshack.co.uk), to represent the classes;
  3. For promotional use, including newsletters, leaflets, posters, banners;
  4. For the general marketing of the school.
  5. No names will be published.
  6. If you do not wish to agree to this clause, or if at any time you wish photos to be deleted from our library, please contact us.
  7. Parents are NOT permitted to take photographs or videos inside or outside our studios.

#### E. Data Protection

1. Dance Shack holds information about our students to enable us to carry out our business as a dance education and training organisation. This information includes the contact details you supply to us.
2. Dance Shack will not disclose your information to any third parties except where the law allows or requires, or where you have given your permission to do so. [GDPR statement can be seen here.](#)

- F. Changes to the terms and conditions
  - 1. Dance Shack reserves the right to change these terms and conditions at any time providing one term's notice is given.
  
- G. Agreeing to terms and conditions
  - 1. By enrolling your son/daughter in classes at Dance Shack you agree to these Terms and Conditions.

### **Dance Shack Monthly Payment - Terms & Conditions - 2023**

- 1. Monthly charges are calculated on 37 classes per year (on average), equally divided into 12 payments.
- 2. No refunds will be given for non-attendance through sickness, holidays or otherwise.
- 3. Six weeks written notice is required if you wish to cancel your monthly payment plan. Any monies outstanding at this point will be charged in the final monthly payment. Similarly, any appropriate reduction in monthly payment will be made in the final monthly payment. **Please note A.6 above:** "One half term's (six weeks) written notice or payment in lieu is required if you wish to withdraw from classes at Dance Shack. For the sake of clarity, the six weeks referred to are term-time, payable weeks, and do not include holiday weeks. This notice period will not apply during or at the end of a child's first term at Dance Shack."
- 4. At least 6 week's notice will be given of any increase in fees.
- 5. Any extra, chargeable items (such as yearly show-fees) will be added to the first appropriate monthly payment, with prior notice.
